### Definitions

These terms and conditions apply to every person registering for the meeting

All references to a date or deadline, mentioned in these terms and on other congress documents, refer to the Central European Time Zone (CET).

Registration for the congress implies the acceptance of these terms and conditions.

### Congress Registration

Registration for FOCUS: Valve 2026 is to be made electronically by using the respective online registration form, provided at the congress website - [www.focusvalve.org](http://www.focusvalve.org).

A letter of confirmation will be sent by e-mail after submission of the completed registration form. Registration fees for different categories of the congress are shown on the registration page [www.focusvalve.org](http://www.focusvalve.org). If the maximum participant capacity is reached, the congress organizers reserve the right to refuse additional registrations.

Registration fee for participants include:

Optionally additional registration fees include:

Travel and accommodation costs are not covered by the registration fee.

### Methods of Payment

All fees include 20% VAT according to the Austrian tax law.

## Cancellation Policy

Notice of cancellation must be made in writing to [valve@maw.co.at](mailto:valve@maw.co.at).

The notification must include all relevant information regarding the bank account to which a possible refund may be remitted (incl. IBAN and BIC). The cancellation will not be effective until a written acknowledgement by MAW is received.

### Written cancellation received:

- Before Monday, August 31, 2026: EUR 50.- cancellation fee
- After August 31, 2026: No refund

In case of over- or doublepayment, refund requests must be made in writing (by e-mail) and sent to [valve@maw.co.at](mailto:valve@maw.co.at). No refunds will be granted for unattended events or early termination of attendance, in case of cancellation of speakers, lack of space in the congress room or any other incidents during the congress which are beyond the control of the congress organizers.

## Letter of invitation

To receive a letter of invitation, participants must first register to the congress and then submit any necessary data (Name as stated in the passport, date of birth, passport number). The letter of invitation does not financially obligate MAW in any way. All expenses incurred in relation to the FOCUS: Valve 2026 congress are the sole responsibility of the participant. Any costs for express mailing of documents must be covered by the participant.

Austrian embassies and consulates are independent decision making agencies for visas. MAW does not intervene on a registrants behalf in case of rejection or for speeding up the procedure.

**IMPORTANT: In case of not being able to attend the congress, having received an invitation letter: Notify [valve@maw.co.at](mailto:valve@maw.co.at) immediately, otherwise MAW will have to report to the according embassy!**

## Limitation of Liability

The congress organizers shall be held liable in the framework of a duty of care as a respectable businessman according to statutory provisions.
